

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approving Ninth Amendment to Credit Agreement between Wells Fargo Bank, N.A. and the White Mountain Apache Tribe)

- WHEREAS, pursuant to Resolution No. 01-00-19, the White Mountain Apache Tribe entered into a credit agreement (the "Agreement") with Wells Fargo Bank (the "Bank") on January 3, 2000; and
- WHEREAS, the terms of the Agreement require an annual review; and
- WHEREAS, the last renewal was made pursuant to Resolution No. 03-2006-89, which expired on June 01, 2006; and
- WHEREAS, the Controller and Treasurer recommend a Ninth Amendment (the "Amendment") to the Agreement, which substitutes the following terms:
 - 1. Term. The last date upon which the Bank will make advances under the Revolving Line of Credit ("RLC") is hereby extended to December 31, 2006; and
- WHEREAS, all other terms and conditions of the underlying Agreement will remain in full force and effect, including a limited waiver of sovereign immunity provided pursuant to Resolution No. 01-00-19; and
- WHEREAS, the Amendment has been reviewed by the Controller, the Treasurer and the Tribal Attorney, who finds that the Amendment will continue to allow the Tribe to use funds under the Revolving Line of Credit for the purposes of addressing the Tribe's daily cash flow requirements; and

WHEREAS, the Tribal Council finds that the Amendment is in the best interests of the Tribe.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

- 1. A Ninth Amendment to the Credit Agreement between Wells Fargo Bank, N.A. and the White Mountain Apache Tribe, is hereby approved and shall include the following terms:
 - A. Term. The last date upon which the Bank will make advances under the Revolving Line of Credit is hereby extended to December 31, 2006.
- 2. The Chairman, or in his absence the Vice-Chairwoman, is hereby authorized to execute the Amendment and any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on August 4, 2006, duly adopted by a vote of EIGHT for and against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
