**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approving payment of funeral and burial expenses of Dennis Massey, Sr.)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, the Tribal Council has been advised that former Tribal Chairman Dallas Massey, Sr.'s father, Dennis Massey, Sr., passed away; and

WHEREAS, Dennis Massey, Sr. was a well respected Pastor of the Canyon Day Miracle Church for many years; and

WHEREAS, the Tribal Council extends its sincere sympathy to Mr. Massey's family; and

WHEREAS, the Tribal Council approves payment of funeral and burial expenses; and

WHEREAS, the Tribal Council finds that such payment is consistent with and pursuant to the Apache way, and is in the best interests of the Tribe and former Tribal Chairman Dallas Massey, Sr.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

1. Payment of funeral and burial expenses of the late Dennis Massey, Sr. is hereby approved.
2. Funds for said payment shall be expended from the Tribe's burial account.
3. The Chairman, or in his absence the Vice-Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on September 6, 2006 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (h),(k), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).











