**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Authorizing Safari Club International to Film Hunts on the Fort Apache Indian Reservation)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, by letter dated September 13, 2006, as attached and incorporated by this reference, Safari Club International has requested to film hunts occurring on the lands of the Fort Apache Indian Reservation, and broadcast said film on a television show, Expedition Safari, as attached and incorporated by this reference; and


WHEREAS, it is the Tribal Council's understanding that each film and broadcast thereof shall acknowledge the Tribe's Wildlife and Outdoor Recreation Division's White Mountain Apache Elk hunt and contact information thereto; and

WHEREAS, the Tribal Council finds that SCI's proposal to be in the best interest of the Tribe, subject to an agreement between SCI and the Tribe that such films and broadcast be not-for-profit, and that in the event of any potential profit derived from the films and broadcasts said profits be shared equally between the Tribe and SCI.

NOW BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

1. SCI's proposal is hereby approved, subject to an agreement between SCI and the Tribe that:
(a) SCI's film and broadcasts of the Tribe's White Mountain Apache Elk hunt be not-for-profit; and (b) in the event that SCI realizes any profit from such films and broadcasts, such profit be shared equally between the Tribe and SCI.
2. The Chairman, or in his absence the Vice-Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on September 20, 2006, duly adopted by a vote of NINE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (f), (h), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

SCI would like to thank you and the White Mountain Apache Tribe for your ongoing support of SCI and our mission to protect the freedom to hunt. I understand that your council is willing to consider allowing Safari Club International's (SCI) television show, Expedition Safari, to film hunts that will take place on the reservation this year. Our show host Mike Rogers would be joined by New York City Police Chief, Michael Scagnelli for these hunts which are scheduled to begin September 23rd, 2006.

It is also my understanding, and commitment to you, that we would be providing the Outdoor Life Network with video footage master copies in High Definition of this show that will air during our nationally televised prime time slot.
