



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

**(Appointing of Roberta Leslie to Theodore Roosevelt School Board and as Liaison
between the Tribe and the BIA and grant school boards)**

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, pursuant to Article IV, Section 1(s) of the Constitution, the Tribal Council has the authority to appoint boards, which would include positions on the Theodore Roosevelt School Board; and

WHEREAS, a vacancy on the Theodore Roosevelt ("TR") School Board has been created by the resignation of Vice-Chairwoman Margaret Baha-Walker; and

WHEREAS, Roberta Leslie did this day come before the Tribal Council to apply for an appointment to the position of member of the TR School Board; and

WHEREAS, Ms. Leslie has 33 years of experience with the Bureau of Indian Affairs Indian Education Program in administration; and

WHEREAS, in her capacity with the BIA, Ms. Leslie worked with the Riverside Indian School of Anadarko, Oklahoma, and gained great insight and familiarity with school operations, administration and educational programs; and

WHEREAS, the Tribal Council finds that the TR School would benefit from the appointment of Ms. Leslie to the TR School Board; and


WHEREAS, the Tribal Council further finds that there exists a need for a liaison between the Tribe and the BIA and grant schools, to provide regular and consistent updates to the Tribal Council and the Tribe's Department of Education on school board actions, as well as school activities, budgets, programs.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

1. Roberta Leslie is hereby appointed to the position of Board Member to the Theodore Roosevelt School.
2. Ms. Leslie is further appointed to act as Liaison to the White Mountain Apache Tribe on BIA and grant schools.
3. The BIA and grant schools are hereby requested to determine whether sufficient funds exist to fund the Liaison position.
4. The Chairman, or in his absence the Vice-Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on November 1, 2006, duly adopted by a vote of NINE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
