
**(Approval of Land Board meeting minutes for July 27, 2006)**



1. **Calvin Mason Sr.**, - Came in with his sister Lorraine to clarify the land site application. According to the papers. Calvin's mother had given him this land because he is the eldest of her children. Years later he turned this over to his sister Lorraine because he had no need for it. Since then Lorraine has been living there and also been planting on field. She also has spoken to the Chairman and he is aware of it. Also, Calvin's daughter Perlina brought papers in saying that her dad had turn this over to her, but the application was never approved by the members nor the council, and when he signed the paper for his daughter the land was already not in his name. Now, Calvin applied for a HIP home on this lot and Lorraine is willing to relinquished part to it to him. She has the papers for the relinquishment and land site application for Calvin. Both applications approved.
2. **Derroll Joe** – Requesting for lot in Hondah, request approved.
3. **Michelle Martinez** – Came in on behalf of Jones Adley. He is applying for a cornfield behind his resident in Seven Mile, which belongs to Emma Pope. Emma brought in the relinquishment form to give a piece of land to Mr. Adley. Raymus showed the board where the field is at on the map. Board approved the relinquishment from Emma Pope and the application for Mr. Adley.
4. **Eva Nash** - Relinquishing a lot back to Tribe, and applying for another different site in Turkey Creek. Board approved both applications.
5. **Nancy Nash** – Requesting for land in Turkey Creek, near the rodeo grounds. Board approved the request.
6. **Karinia Nash** – Requesting for land in Turkey Creek, Board approved the request.
7. **Leona Hawthorne** – Requesting for land that belonged to her late brother Lloyd Kane Sr., The Children of Mr. Kane have put in a request through court and the hearing is still pending. The board suggest that she wait to see the outcome at the courts and to bring the papers of the results back in to the land office.
8. **Barney Burnette /Marie Quay**– Came in requesting for land by the street lights in Whiteriver, Marie Quay stated that the land site belonged to her, and she wanted to relinquished it to Mr. Burnette. Raymus and McDaniel are not aware of this land belonging to Mrs. Quay, the request was put on hold until they check with the council. Also Mrs. Quay inquiring on some cornfield in North fork, the cornfield once belong to Betty Skidmore who is deceased, and Mrs. Quay would like the cornfield in her name. Raymus will check into this.
