(Approval of Land Board meeting minutes for August 24, 2006)



Meeting opened in prayer by Pedro Johnson:

1. Scott and Pam Dureya – Requesting for land site in North Fork, brought in paper that the Livestock association committee had approved. Board approved the request.
2. George Gregg III – Mr. Gregg requesting for additional land to his land site in Cedar Creek for his horse. The housing authority won't allow for him to keep his horse on his site so he is requesting for land outside of his fence, only temporarily. Justin will ask the Housing board about this situation because there are others that have that same request. Board approved the request for 90 days.
3. Joann Sanchez – Requesting for land in the Sawmill area, but was told there is no site available in Sawmill, so she was told by Jennifer Sanchez that she could apply for the piece of land by her landsite that belonged to her father which was once a cornfield. Board approved the site for Seven Mile by Jennifer Sanchez.
4. Jennifer Sanchez – Applying for the landsite that her house is on, she is going through a dispute with another family member and wants to update her application. She has been living on this site for 15 years and never had any problems with it. Board approved the request.
5. Dell White – Requesting for landsite in Hondah and cornfield in Quintero Springs, both request approved.
6. Curtis Bourke – Requesting for land in East Fork. Board approved the request.
7. Ronnie Peaches – Requesting for land near Harry Brewer, McDaniel told the board that is was available. Board approved the request.
8. Marvin Kessay Sr., - Requesting for land in Cibecue on Mustang Ridge, board approved the request.
9. John Andreas for Anita Joy. – Came before the board because of some conflict with the neighbor on the road that he had put in to their home in Another World. They have been living in this area for 8 years and in the winter they always have a hard time getting to their house plus the propane truck, so this summer he had some gravel put down worth \$1300.00 and it also assists the neighbors. McDaniel states that there is a proposal road but it is in a different route, the board suggest that they go to the Roads or Housing department to verify the proposal. McDaniel will also check into this.
10. Castorena Cosay, Margurita Tessay, Lydia Tessler and Melaine Tessler – Requesting for their late mother's Viola Tessler farmland. Board approved the request.

11. Manual Dazen – Requesting for additional land to their present site in North Fork. They want the front area and the side area. Board approved 10ft on the front area but the side is already taken. He also inquired on the farmland in Big Canyon, Raymus suggested that he put this in his name on application.
12. Darryl Metts – Requesting for land in Hondah a lot that is in Murphy Carol's name, the board told Mr. Metts that he would have to ask Mr. Carol for a relinquishment. He also asked for a site in the same area for a business site but the board decided that McDaniel would have to check into this.
13. Janice Massey – Requesting for the land that they are living on to be put in their name. Paper shows that this land was already relinquish to Randall Massey Jr, by his mother Louella Massey. Board approval as a renewal on application.
14. Annalita P. Zahgotah – Requesting for land in Whiteriver, also brought in relinquishment paper signed by Johnny Kindelay. Delbert Zahgotah also has inquired on this land site and others need to be notified on this matter. Justin has asked to for all to be notified to attend the next meeting on September 28th 2006 to clarify this land site.
15. Anthony Armstrong – Requesting for land in Sawmill, according to McDaniel this land site is already assigned.
16. Michael Reed – Requesting for land in Dry Valley, request put on hold.
17. Dewey Bahlen – Requesting for land in Seven Mile, land already assigned. Board denied the request.
18. Cindy Kaytoggy – Relinquishing a land site back to the tribe, board approved the request.
19. Kristie Cosay – Requesting for land site but application incomplete.
