



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

**(Authorizing Budget for and Appointment of Grant Writer II Position within Planning and
Community Development Department)**


- WHEREAS**, pursuant to Article IV, Sections 1(a) and 1(k) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe, and to expend funds according to a budget; and
- WHEREAS**, pursuant to the cost containment measures adopted by Resolution No. 12-2006-423, no further creating, hiring or appointing any new positions shall be made by the Tribal Council without first being reviewed and approved by the Budget and Finance Committee; and
- WHEREAS**, in August, 2006, the Tribe's Budget and Finance Committee approved the creation of the Grant Writer II position within the Tribe's Planning and Community Development Department; and
- WHEREAS**, the Tribe's Budget and Finance Committee approved funding the Grant Writer II position at a total cost, inclusive of salary, benefits and related expenses, of \$64,500 a year; and
- WHEREAS**, the Tribal Council finds that the Grant Writer II position is important to raising funds necessary to provide vital services for the Tribe; and
- WHEREAS**, the Tribal Council further finds that the proscription against creating, hiring or appointing any new positions, under Resolution No. 12-2006-423, should be amended to allow an exception for the Grant Writer II position, because of the income potential behind the grants that the position may develop.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

1. Resolution No. 12-2006-423 is hereby amended to allow for an exception for the Grant Writer II position for the reasons set forth herein.
2. A budget of \$64,500 is hereby approved to pay the annual cost of staffing the Grant Writer II within the Planning and Community Development Budget.
3. The Director of Planning and Community Development is hereby authorized to appoint or otherwise hire a qualified individual for the position of Grant Writer II.
4. The Chairman, or in his absence the Vice-Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on November 29, 2006, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (h), (i), (j), (k), (l), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
