



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Appointing a New Committee for the Miss White Mountain Apache Rodeo Queen)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, Miss White Mountain Apache Rodeo Queen, Jovee Hernandez, through her mother, Glenda Hernandez, did this day come before the Tribal Council requesting that there be a committee appointed for the Miss White Mountain Apache Rodeo Queen; and

WHEREAS, Miss White Mountain Apache Rodeo Queen recommends the appointment of Joe Hernandez, Glenda Hernandez, Jandi Aiello, Gwendena Lee Real Bird, Evalene Tulene, Joy Cody, Candy Lupe, Kathy Antonio and Evangeline Gatewood to the Committee for the Miss White Mountain Apache Rodeo Queen; and

WHEREAS, the Tribal Council finds that the recommended appointments to the Committee are in the best interests of the Committee and the Tribe; and


WHEREAS, the Tribal Council recognizes that the Committee will be hosting fundraising events, and other events to promote the Miss White Mountain Apache Rodeo Queen and the mission of the Committee.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that Joe Hernandez, Glenda Hernandez, Jandi Aiello, Gwendena Lee Real Bird, Evalene Tulene, Joy Cody, Candy Lupe, Kathy Antonio and Evangeline Gatewood are hereby appointed to the Committee for Miss White Mountain Apache Rodeo Queen.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Committee to solicit and receive financial donations from any person or entity for the control and use by the Committee for Committee purposes as approved by the Tribal Council and subject to such additional regulations as the Tribal Council may establish, and further provided that no funds or property will be used for the personal gain of any Committee member or other person.

The foregoing resolution was on December 13, 2006, duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
