

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approval to enroll deceased infant, Hannah Nikita Skacy)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, the Tribal Council has been informed that Terrance Skacy and Kristy DeClay's daughter, Hannah Nikita Skacy has expired; and

WHEREAS, the child was not yet enrolled with the White Mountain Apache Tribe; and

WHEREAS, the child qualifies for membership pursuant to the Enrollment Code and the Tribal Constitution; and

WHEREAS, the parents are requesting approval to enroll their daughter to become eligible for funeral and burial expenses.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants tribal membership for Hannah Nikita Skacy.

The foregoing resolution was on <u>February 15, 2007</u>, duly adopted by a vote of <u>EIGHT</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
