



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approval of hiring six Grant Writer I's within the Grant Development Program of the Planning and Community Development Department)**

**WHEREAS**, the Tribe's Budget Committee in March of 2007 approved the creation of the Grant Writer I position within the Tribe's Planning and Community Development Department; and

**WHEREAS**, the Tribal Council by Resolution needs to approve the budget for the Grant Writer I position; and

**WHEREAS**, the Tribe's Budget Committee approved funding the Grant Writer I position with a salary of no more than \$42,000 a year; and

**WHEREAS**, the Tribe's Budget Committee approves creating three Grant Writer I positions with a salary of no more than \$42,000 a year; and

**WHEREAS**, the Grant Writer I positions will include an Economic Development Grant Writer, a Grant Writer who will focus on preparing grants that would benefit the Westside (Districts I and II) and a Grant Writer who will focus on developing grants for the Eastside (Districts III and IV); and

**WHEREAS**, the Tribe's Budget Committee approved funding the total cost of the Grant Writer II position with salary, benefits and related expenses of \$193,500 year; and

**WHEREAS**, the Planning Department shall generate sufficient funds from grants to pay for on-third of the \$198,240 of the cost of the new grant writers or \$66,080 a year.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that:

1. The approved budget sets the salary for the Grant Writer I position at no more than \$42,000 a year.
2. That the approved budget of \$198,240 to pay the annual cost of hiring three Writer I's within the Planning and Community Development Budget.
3. The Grant Writer I positions shall include an economic development, Westside (Districts I and II) Grant Writer and an Eastside (Districts III and IV) Grant Writers.
4. The Planning Department shall generate sufficient funds from grants to pay for one-third of the \$198,240 of the cost of the new grant writers or \$66,080 a year.

The foregoing resolution was on March 14, 2007, duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (c), (h), (i), (j), (k), (l), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
