**(Approval of Land Board meeting minutes for March 29, 2007)**



Opened up in Prayer by Pedro Johnson at 9:15 AM.

1. Ardella Alsenay – Requesting for a survey to be done in Whiskey Flats at her sister's residence Lucinda Hilton. Stated that they have been requesting for this for a long time. The neighbor has been complaining about the post that they put in. Mc Daniel requested for her to go to Housing to get the measurements for their site. She will return with the papers and McDaniel will do the survey then.
2. Audrey Susan – Requesting to relinquish her landsite located in Whiteriver to Kateri Goseyun. Board approved the request.
3. Katerie Goseyun – Applying for the landsite relinquished to her by Audrey Susan, board approved the application.
4. Jacqueline Yazzie – Applying for Landsite and Farmland that belonged to her late mother Rita Yazzie. She was the power of attorney for her mother and she has 4 other siblings, yet when they had probate they gave the farmland to her mother's sisters and later was given to Timo Quintero, so they were left with no farmland. 7. Blessing Goklish – Requesting for the farmland in Forest Dale to be put in her name, her grandmother had given her this land and she has been planting since. Board approved the request but request for Max Goklish to sign the relinquishment form. Hold until next month.
8. Joreen Foster – Requesting for land to get HIP home built. The land she is requesting for is already taken. She would also have to turn present lot to someone to apply for another landsite. She will return when she gets these papers done.
9. Melissa Walker – Requesting for land in East Fork near her parents residence. Board approved the request.
10. Cynthia Adgeron – Requesting for a different area in Cibecue, because of the sewer and water. But at the end decided to take the present lot, will see what environmental testing goes.

11. Ronald Larzelere – Requesting for lot in Cibecue that was given to him by his grandmother and wants it surveyed. Board request for livestock to check into this it may be their land. Application on hold.

17. Armonya Hume – Requesting for landsite in Whiteriver , which is being relinquish to him by Jimmy Cohoe, Board approved both request.
