

## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approval to grant tribal relinquishment request of Lewis Justin Anderson)

WHEREAS, tribal member Lewis Justin Anderson, dob: 07/12/1988, has requested that his tribal membership with the White Mountain Apache Tribe be relinquished so that he may become eligible for enrollment with the Sisseton-Wahpeton Oyate Sioux Tribe; and

WHEREAS, the necessary documents of relinquishment of head rights was signed by Lewis Justin Anderson in the presence of a Notary Public on the April 11, 2007, and are attached hereto; and

WHEREAS, the Tribal Enrollment Committee approved this relinquishment request at their meeting on May 29, 2007.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Lewis Justin Anderson and his tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to, hunting, fishing, and recreational privileges upon the Fort Apache Indian Reservation.

**BE IT FURTHER RESOLVED** by the Tribal Council that it hereby directs the Office of Vital Records to remove Lewis Justin Anderson from the membership rolls of the White Mountain Apache Tribe.

The foregoing resolution was on <u>June 11, 2007</u>, duly adopted by a vote of <u>NINE</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section II of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Further, I understand that once my relinquishment is accepted by Tribal Council Resolution, it will be TOTAL AND IRREVOCABLE. I will no longer have fishing or hunting privileges on the Fort Apache Indian Reservation; no rights to homesite or farmland assignments, claim or title to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission Act. Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the resolution date accepting my relinquishment, all my livestock and personal property.
