



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Authorizing Campaign Contribution for Mary Kim Titla, Democratic Candidate, U.S.  
Congressional District No. 1)**

- WHEREAS,** pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** pursuant to Resolution No. 06-2007-216, "Supporting Mary Kim Titla Democratic Candidate, U.S. Congressional District No. 1", the Tribal Council did support the candidacy of Mary Kim Titla for the U.S. Congress as a Representative for District 1; and
- WHEREAS,** Ms. Titla's Treasurer, Patsy Cohoe, did this day present Ms. Titla's request for campaign contributions in the amount of \$2,300 for both the Primary and General Election campaign cycles, for a total of \$4,600; and
- WHEREAS,** the Tribe's Legal Department has advised that such a contribution to Ms. Titla is allowable under federal laws, as are individual campaign contributions, subject to certain limitations on combined totals; and
- WHEREAS,** after careful consideration, the Tribal Council concurs and finds it to be in the best interests of the Tribe that the Tribe make two \$2,300.00 contributions to Mary Kim Titla, one for the Primary and one for the General Election campaign cycles, and the second contribution should be subject to a successful election in the Primary.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that:

1. Two \$2,300 contributions are hereby authorized for the Mary Kim Titla for Congress campaign, of which one shall be for the Primary Election cycle, and one for the General Election campaign cycle subject to her successful election in the Primary.
2. Payments described hereunder shall be made from the Legal Department budget.
3. The Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all document necessary to effectuate the intent of this Resolution.

The foregoing resolution was on September 5, 2007, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
