



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**


(Resolution Enacting Ordinance No. 232, Adopting Amendments to Natural Resource Code)

- WHEREAS,** pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** pursuant to Resolution No. 08-2007-307, "2007 Amendments to Natural Resource Code," Tribal Forestry proposed and the Council approved amendments to Sections 1.1, 1.1(N), 1.8, 1.14, and 1.15 of the White Mountain Apache Natural Resource Code (the "Code") on August 8, 2007, subject to posting for the purposes of a comment period; and
- WHEREAS,** Article XV of the Constitution of the White Mountain Apache Tribe requires the posting of proposed amendments or ordinances in each district for at least ten (10) days before final action by the Council; and
- WHEREAS,** the Tribal Council Secretary reports by a memorandum dated August 23, 2007, as attached and incorporated by this reference, that Resolution No. 08-2007-307 and the proposed amendments were posted on August 13, 2007, through August 23, 2007, and during the required ten (10) days of posting, comments were to be sent to the Tribal Forester; and
- WHEREAS,** Tribal Forestry reports this day that no comments were received and thus recommends that Ordinance No. 232 be enacted; and
- WHEREAS,** the Tribal Council has considered that there have been no comments on the proposed Amendments to the Natural Resource Code and finds that enactment of Ordinance No. 232 to be in the best interests of the Tribe.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that Ordinance No. 232, "2007 Amendments to Natural Resource Code" is hereby enacted.

BE IT FURTHER RESOLVED by the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all document necessary to effectuate the intent of this Resolution.

The foregoing resolution was on September 25, 2007, duly adopted by a vote of NINE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (f), (h), (i), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).












