



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approval to enroll deceased child, Brandi Latifah Palmer)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, the Tribal Council has been informed that Brandi Latifah Palmer, has expired; and

WHEREAS, Brandi Latifa Palmer was an infant child of enrolled member (mother) of the White Mountain Apache Tribe; and


WHEREAS, the child was not yet enrolled with the White Mountain Apache Tribe; and


WHEREAS, the child qualifies for membership pursuant to the Enrollment Code and the Tribal Constitution; and

WHEREAS, the parent, Ronita Palmer, is requesting approval to enroll her child to become eligible for funeral and burial expenses.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants tribal membership for Brandi Latifah Palmer, an infant child of Ronita Palmer, who is an enrolled member of the White Mountain Apache Tribe.

The foregoing resolution was on October 3, 2007, duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
