



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving Appointment of 2008 Miss White Mountain Apache Rodeo Queen Committee)**

**WHEREAS,** pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and to appoint subordinate committees, commissions boards, advisory or otherwise; and

**WHEREAS,** there is a need to appoint a new Miss White Mountain Apache Rodeo Queen Committee to prepare for the 2008 White Mountain Apache Tribal Fair and Rodeo; and

**WHEREAS,** by Resolution No. 12-2006-406, "Appointing a New Committee for the Miss White Mountain Apache Rodeo Queen," certain individuals were appointed to the Committee; and

**WHEREAS,** Glenda Hernandez did this day present a request of the Committee for the Tribal Council to appoint new members, and that the following individuals have indicated an interest to serve as Commissioners and are hereby recommended:

**WHEREAS,** the Tribal Council concurs with the request made herein and finds that the individuals requested should be appointed to the Commission, and that such appointments would be in the best interest of the Tribe and the 2008 Tribal Fair & Rodeo.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby appoints the above twelve named individuals to the Miss White Mountain Apache Rodeo Queen Committee to serve in the position of Commissioner thereto.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Committee to solicit and receive financial donations from any person or entity for the control and use by the Committee for Committee purposes as approved by the Tribal Council and subject to such additional regulations as the Tribal Council may establish, and further provided that no funds or property shall be accounted for and that no funds will be used for the personal gain of any Committee member or other persons.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby rescinds all prior resolutions pertaining to the Miss White Mountain Apache Rodeo Queen Committee.

**Resolution No. 10-2007-391**

The foregoing resolution was on October 9, 2007, duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
