



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approving payroll deduction for Verda Lupe)

- WHEREAS,** pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** a request for payroll deduction was made by Verda Lupe for \$1,218.12 in the form of an interest free loan to be paid back through payroll deductions by Ms. Lupe over a period of five pay periods; and
- WHEREAS,** the amount of \$1,218.12 should be made payable to White Mountain Apache Housing Authority; and
- WHEREAS,** by Resolution No. 06-2007-256, "Approving Cost Containment Measures for FY 2007-2008," payroll deductions were disallowed; and
- WHEREAS,** the Tribal Council finds Resolution No. 06-2007-256 should be amended for the limited purposes described herein, and that such assistance is appropriate in the form of payroll deduction to be paid at the rate of \$250 through a payroll deduction.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

1. An appropriation of \$1,218.18 is hereby approved for the purposes described herein, and said amount shall be deposited into the Tribal Contributions Account.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all document necessary to effectuate the intent of this Resolution.

The foregoing resolution was on October 9, 2007 duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

**RESOLUTION OF THE

(Authorizing Appropriation of \$2,500 for Banquet Honoring Apache Hot Shots)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, the Apache Hot Shot Crew has received national recognition for their work saving forests, communities and lives from wild fires; and

WHEREAS, in honor of the Apache Hot Shots, the Tribal Council finds that a banquet at Hon-Dah is appropriate, for which an appropriation of \$2,500 is in order.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that an appropriation of \$2,500.00 is hereby authorized for the purposes of funding a banquet at Hon-Dah, honoring the achievements of the Apache Hot Shot Crew.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.
