

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approving Native Vision Lacrosse Mini Clinic)

WHEREAS, members of the Tribal Council of the White Mountain Apache Tribe are duly elected representatives of the people of their respective districts, and among the many issues of concern to the Council are the health and well-being of its Tribal members; and

where we will be a service projects to evaluate infectious disease and behavioral health problems which exist in the population and to develop appropriate interventions which seek to decrease or alleviate these problems; and

WHEREAS, Johns Hopkins, in partnership with the White Mountain Apache Tribe, has agreed to assist in efforts to find ways to raise the self-sufficiency of Indian communities to the highest possible level and to promote and celebrate all that is healthy and positive in the lives of our Native Youth through the Native Vision Year Round Recreation League program; and

WHEREAS, Native Vision Lacrosse Mini Clinic, scheduled for November 2-3, 2007 in Whiteriver, Arizona, will launch the first such event of the Native Vision League program; and

WHEREAS, the Tribal Council finds that the Clinic and the Native Vision League program to be in the best interest of the youth and the White Mountain Apache Tribe; and

WHEREAS, the Tribal Council further finds that the Tribe, as host for launching the first ever Native Vision Year Round Recreation League program, should provide, as in years past, the following: lodging at Hon-Dah Resort for visiting athletes and JHU Baltimore coordinators, and that such in-kind support should be provided during the mini clinics to be hosted on the Fort Apache Indian Reservation throughout the League program's existence.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

- 1. The Native Vision League Program is hereby approved.
- 2. The Native Vision Lacrosse Mini Clinic, scheduled for November 2-3, 2007, is hereby approved, as are subsequent League program events.
- 3. The Johns Hopkins Center for American Indian Health, in partnership with the NFL Players Association, is hereby authorized to serve as the coordinating group for the Native Vision Year Round Recreation League program in Whiteriver, Arizona.
- 4. In-kind support is hereby authorized for the League program, and shall consist of lodging at Hon-Dah Resort for visiting athletes and JHU Baltimore coordinators, as may be available, and such in-kind support shall be provided during the mini clinics to be hosted on the Fort Apache Indian Reservation throughout the League program's existence.

5. Hon-Dah Resort is hereby requested to provide the in-kind support required herein.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence the Vice-Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on October 10, 2007, duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1(a), (b), (h), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
