



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Supporting Canyon Day Rodeo)**

**WHEREAS**, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS**, the Canyon Day Rodeo has historically brought family, friends and tourists together to celebrate the culture of the White Mountain Apache Tribe and the sports of rodeo; and

**WHEREAS**, Council Member Noland Clay, District IV, did this day request support for the Canyon Day Rodeo, scheduled for April 10-13, 2008, according to the following budget:

Total		\$6,200.00

**WHEREAS**, the funds and in-kind contributions provided will ensure a successful event and in turn foster economic development; and

**WHEREAS**, Council Member Clay further seeks authority to solicit contributions; and

**WHEREAS**, the Tribal Council concurs with the request and finds it in the best interest of the community of Canyon Day and the Tribe's overall economic development.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that:

1. The budget presented herein is approved for the purpose of supporting the Canyon Day Rodeo.
2. The enterprises identified herein are hereby directed to provide funds for the identified purposes.
3. Council Member Clay shall hereby have the authority to solicit contributions to the Canyon Day Rodeo.
4. The Community of Canyon Day shall be responsible for submission of an accounting of all income and expenditures related to the support provided herein, with receipts thereto, to the Tribe's Chief Financial Officer within five business days of the event.

**Resolution No. 03-2008-52**

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on March 12, 2008, duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (h), (i), (k), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
