WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, Raymus Albert, Land Office Director, has come before the Tribal Council this date requesting approval of the Land Board meeting minutes for February 28, 2008; and

WHEREAS, the Tribal Council, after reviewing the Land Board meeting minutes, agrees that the Land Board meeting minutes for February 28, 2008 should be approved but will table #8 Pauline Beach & family request.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Land Board meeting minutes for February 28, 2008 and table #8 Pauline Beach & family request.

The foregoing resolution was on July 22, 2008, duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (h), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Meeting up with a prayer by Pedro Johnson at 9:15 a.m.

1. **Louella Massey** – Requesting for land in Whiteriver, Sawmill area. Ms. Massey got a letter from Ms. Sanchez stating that the land is vacant and that they never owned the land. The board suggested that McDaniel checks out this land site, will let her know at next month's meeting.
2. **Mercy Gass** – Wants McDaniel to survey her landsite again, claims that the neighbors still go through her land as a driveway. Board suggested for McDaniel to recheck the site and to resurvey for Ms. Gass. Board wants someone to be home when McDaniel goes there to survey.
3. **Abigail Parker** – Checking up the application she had put few months back for a site near the fair grounds. Raymus will check with the council at the next council meeting. On Hold.
4. **Patsy Armstrong** – Applying for the landsite where her house is at in Cedar Creek, Her late father Spencer Armstrong's resident. Raymus said that she will need her sister Dorita Johnson to relinquish it to her. On Hold.
5. **Saralyn Edwards**- Requesting for land in East fork near Annie Yardley resident, she brought relinquishment from Gussie Edwards. Board approved the request. Mc Daniel to survey.
6. **Salina Alsenay**- Requesting for land in Dry Valley, Board approved the request.
7. **Emilie Hernandez** – Requesting for land in Dry Valley, Board approved the request.
8. **Pauline Beach and Family** – Ms. Beach relinquishing her farmland in Cibecue to her children : Preston Jr., Jonah Sr., Jonah Jr., Lambert, Darlene, and Belinda Susan. Board approved the request.
9. **Gary Hill** – Requesting for grazing land for his horse and cattle. He explained and showed pictures for his pen for his livestock behind the house in Rainbow City, brought some support letters from neighbors. The pen that the livestock are in now is very small, need a bigger area for them. The board suggested that McDaniel help him find some land. McDaniel did find one south Whiteriver near Chinatown Subdivision. Board approved it for 90 days, and to check with Phil Stago.
10. **Philip Hagadorn/Subway** – Requesting for land to build Subway, near the Game and Fish office, Board approved the request.
11. **Michael Clendon** – Requesting for land in Canyon Day, Board approved the request.

12. **Leticia Colelay** – Requesting to switch land sites with Teddy Guy in Yucca Flats, She claims that Mr. Guy is willing to switch, so the board suggested for her to get Mr. Guy to sign land over to her. Will return next month.
13. **Cynthia Dale for Wilbur Dale** – Requesting for land in Fort Apache, and relinquishing site in Hondah back to the Tribe. Board approved the request.
14. **Sonja Burnette** – Checking up on applications for her children, Shermalyn and Kevin Shorty. They are applying for land near their mothers in Whiteriver. Board approved the request. Also, she stated that the Lupe family are going beyond their boundary with their fencing. McDaniel is to check into this and to survey it.
15. **Van Bahlen** – Applying for land in Seven Mile up above the Seven Up subdivision. Board suggest for the Livestock approval. On Hold.
