

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approval to grant tribal relinquishment request of Patsy Kasey Zahgotah)

WHEREAS, tribal member (Patsy Kasey Zahgotah, dob: 01/04/1950, daughter of Lester Kasey and Inez Starr, has requested that her tribal membership with the White Mountain Apache Tribe be relinquished so that she may become eligible for enrollment with the San Carlos Apache Tribe; and

WHEREAS, the necessary documents of relinquishment of head rights was signed by Patsy Zahgotah in the presence of a Notary Public on October 29, 2008, and are attached hereto and incorporated by this reference; and

WHEREAS, the Tribal Enrollment Committee approved this relinquishment request at their meeting on November 03, 2008.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Patsy Kasey Zahgotah and her tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to, hunting, fishing, and recreational privileges upon the Fort Apache Indian Reservation.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs the Office of Vital Records to remove Patsy Kasey Zahgotah from the membership rolls of the White Mountain Apache Tribe, subject to proof of enrollment by the San Carlos Apache Tribe within thirty (30) days of the date of this Resolution.

BE IT FURTHER RESOLVED by the Tribal Council that in the event that the San Carlos Apache Tribe does not provide proof of enrollment to the Office of Vital Records, this Resolution shall be null and void and without force or effect.

The foregoing resolution was on <u>January 14, 2009</u>, duly adopted by a vote of <u>TEN</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section II of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the resolution date accepting my relinquishment, all my livestock and personal property.
