

## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

## (Reinstating the Tribal Council and essential staff to a 40 hour work week)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS,** the Tribal Council has previously adopted Resolution No. 11-2008-272, wherein tribally funded positions were reduced to a 32 hour work week, excluding certain exempt positions mentioned therein; and

WHEREAS, as a result of this Resolution, all Tribal Council and their staff and many essential tribal positions were reduced to a 32 hour work week; and

WHEREAS, the Tribal Council has reconsidered this reduction in light of the need to maintain an effective Tribal government and recommends that the following positions return to a 40 hour work week effective March 13, 2009: the Chairman, the Chairman's Executive Assistant Jerry Gloshay, Jr., the Vice-Chairwoman, the Vice-Chairwoman's Executive Assistant Collette Altaha, Tribal Council, the Tribal Council Secretary, the Treasurer, the Controller/CFO, the Human Resource Director, the staff of the Legal Department, the staff of the Tribal Prosecution Office, the Grants and Contracts Manager, the Administrative Manager, one Tribal telephone operator, Judy Massey, the Tribal Council Administrative Assistant, Markina Cosay, Data Entry and Yvette Yazzie, Budget Specialist; and

**WHEREAS,** the Tribal Council finds that it is in the best interests of the Tribe to reinstate the above referenced positions to a full time 40 hour work week.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby reinstates the following positions to a 40 hour work week effective March 13, 2009: the Chairman, the Chairman's Executive Assistant Jerry Gloshay, Jr., the Vice-Chairwoman, the Vice-Chairwoman's Executive Assistant Collette Altaha, the Tribal Council, the Tribal Council Secretary, the Treasurer, the Controller/CFO, the Human Resource Director, the staff of the Legal Department, the staff of the Tribal Prosecution Office, the Grants and Contracts Manager, the Administrative Manager, one Tribal telephone operator and Judy Massey, the Tribal Council Administrative Assistant, Markina Cosay, Data Entry and Yvettte Yazzie, Budget Specialist.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that in the event of any inconsistency between this Resolution and any other Resolution or Policy of the Tribe, this Resolution shall govern, accordingly the positions mentioned herein are exempt from the application of Resolution No. 11-2008-272.

## **Resolution No. 03-2009-64**

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on March 3, 2009, duly adopted by a vote of EIGHT for, ONE against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
