

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approving W.O.R.D. 2009-2010 Non-Member Outdoor Recreation Regulations)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, the Tribal Wildlife and Outdoor Recreation Division has come before the Tribal Council this date and requested approval of the Non-Member Outdoor Recreation Regulations for 2009-2010; attachments include 2008 Outdoor Recreation Regulations along with a list of Changes for 2009-2010; and

WHEREAS, the purpose of the Regulations is to provide sustainable use of Tribal recreational and natural resources, and promote economic development; and

WHEREAS, the recreational-use seasons, prices, possession limits, prohibitions and regulations are based on sound biological, business, and sustainable use principles; and

WHEREAS, the Tribal Council concludes that the Non-Member Outdoor Recreation Regulations for 2009-2010, as amended herein, be approved by the Tribal Council.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Non-Member Outdoor Recreation Regulations for 2009-2010, as amended and incorporated by this reference, are hereby approved.

The foregoing resolution was on APRIL 23, 2009, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (f), (h), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
