

## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

## (Approving Sponsorship by the Tribal Council of Miss White Mountain Apache Banquet and Related Events)

- WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS, the Tribal Council of the White Mountain Apache Tribe hereby recognizes that the official Goodwill ambassador of the Tribe is Miss White Mountain Apache Queen, and the Tribal Council of the White Mountain Apache Tribe has supported the reign of the Tribal Queen and Miss White Mountain Apache Princess since its commencement of pageantry to facilitate and promote the cultural, social, and spiritual awareness of the White Mountain Apache people.
- WHEREAS, Kelly Nylene Dazen, the 2008-2009 Miss White Mountain Apache, and Queen Committee members, due to lack of budget, request assistance from the Tribal Council; and requests use of Activity Center of the White Mountain Apache Tribe with fee for use waived herein.

WHEREAS, the request for assistance is as follows:

WHEREAS, the Tribal Council finds that payment of \$5,000.00 from the Tribal Contributions Account to be in the best interest of Miss White Mountain Apache and Queen Committee; and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe feels that as a representative of the Tribe, Miss White Mountain Apache should be given priority in using the Activity Center.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that:

1. As appropriation of \$5,000.00 is hereby authorized for the purposes described herein, and said amount shall be deposited by the Treasurer into the Tribal Contributions Account and all affected budgets shall be adjusted accordingly.

- 2. An expenditure from the Tribal Contributions Account in the amount of \$5,000 is hereby authorized for Miss White Mountain Apache Tribe and the Queen Committee for the purposes described herein.
- 3. The Miss White Mountain Apache and the Queen Committee should be give priority in scheduling the use of the Activity Center.
- 4. The Chairman, or in his absence, the Vice-Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>June 24, 2009</u>, duly adopted by a vote of <u>SIX</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (r), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
