

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approving MOA with IHS and Addendum to Conduct a Groundwater Study Project PH09-T75; and Whiteriver Surface Water Treatment Plant, PH09-D95)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, inter alia,

the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare

of the Tribe; and

WHEREAS, the U.S. Indian Health Service (IHS) desires to enter into a Memorandum of Agreement (MOA) with

the White Mountain Apache Tribe for two projects: (1) Conduct an in depth groundwater study of the Carrizo Wells and Columbine Springs (\$62,600.00) (PH09-T75); and (2) Whiteriver Surface Water

Treatment Plant MOA Amendment No. 1 (1,064,900,00) (PH09-D95); and

WHEREAS, the two projects are from the IHS Sanitation Deficiency System list and have been funded with the

American Recovery and Reinvestment Act of 2009, or "stimulus" funds, also requiring an Addendum

to the MOA's; and

WHEREAS, upon completion of such service by the IHS, the water and sewer connections will be transferred to

the Tribe or individual home owner as appropriate; and

WHEREAS, the Tribal Council finds that the MOA, Amendment No. 1 to MOA and Addendums are in the best interest of the Triba as the facilities are needed for tribal members and homefits derived from the

interest of the Tribe as the facilities are needed for tribal members and benefits derived from the

facilities will offset damages realized from the lost use of the transferred land.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Memorandum of Agreement to construct two projects:(1) Conduct an in depth groundwater study of the Carrizo Wells and Columbine Springs (\$62,600.00) (PH09-T75); and (2) Whiteriver Surface Water Treatment Plant MOA Amendment No. 1 (\$1,064,900.00) (PH09-D95).

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Addendum to the Memorandum of Agreement and Amendment No. 1 for project number (2) for these projects.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>August 14, 2009</u> duly adopted by a vote of <u>TEN</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (b), (h), (i), (j), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
