

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Authorizing Repair of Tribal Vehicles for Councilmen Arnold Beach and Victoria Brewer)

WHEREAS, pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache

Tribe, inter alia, the Tribal Council has the authority to represent the Tribe and act in all

matters that concern the welfare of the Tribe: and

WHEREAS, the White Mountain Apache Tribe is responsible for the maintenance of vehicles issued to

Tribal Council members; and

WHEREAS, Councilman Arnold Beach Sr. requests that the Tribal Council provide financial support of

approximately seven thousand (\$7,000) dollars that is needed to repair and maintain his tribally

issued vehicle; and

WHEREAS, Councilwoman Victoria Brewer petitioned the Tribal Council to consider providing

approximately seven hundred (\$700) dollars to cover the costs associated with maintenance of

her tribally issued vehicle; and

WHEREAS, the Tribal Council recognizes the importance of maintaining Tribal vehicles for Tribal Council

representatives to ensure that they can adequately represent their constituents and to provide for the safety of the Tribe's public officials and finds it in the best interest of the Tribe to provide approximately seven thousand (\$7,000) dollars for the maintenance of Councilman Arnold Beach's Tribal vehicle and seven hundred (\$700) dollars for the costs of repairs associated with

Councilwoman Victoria Brewer's Tribal vehicle.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes Councilmen Arnold Beach an allotted amount of approximately seven thousand (\$7,000) dollars for the purpose of repairing and maintaining his Tribal vehicle and further authorizes Victoria Brewer to receive approximately seven hundred (\$700) dollars for the repair of her Tribal vehicle.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>December 30, 2009</u>, duly adopted by a vote of <u>SEVEN</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
