

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approving 2009 HIP Selections)

WHEREAS, pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe: and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe has been advised by the Housing Improvement Program (HIP) Coordinator, Albert Standing Sr., that it is important that the Tribe authorize the selection of persons eligible for the Housing Improvement Program for the Fiscal Year 2009; and

WHEREAS, Housing Improvement Program homes and the construction of those homes are in compliance with the Housing Improvement Programs grant; and

WHEREAS, Albert Standing Sr., on behalf of HIP, recommends that the Tribal Council authorize the construction of four new homes for the FY 2009 Housing Improvement Program contract; and

WHEREAS, the final candidates and HIP selections are as follows: Christine and Ira Sanchez, Juanita Skidmore, Rosina Russell, and Mary Massey; and

WHEREAS, the applicants all meet the requirements to receive assistance under the Housing Improvement Program and the Tribal Council finds it in the best interest of the Tribe to approve of the HIP selection recommendations mentioned herein.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the HIP selection recommendations of Christine and Ira Sanchez, Juanita Skidmore, Rosina Russell, and Mary Massey for participation in the Housing Improvement Program.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>January 14, 2010</u>, duly adopted by a vote of <u>NINE</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
