

## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

## (Temporary Promotion to Acting Positions Pending Investigation)

WHEREAS, pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and

act in all matters that concern the welfare of the Tribe; and

WHEREAS, pursuant to Resolution No. 02-2010-31, several Tribal employees were suspended,

pending an investigation; and

WHEREAS, the following individuals shall be placed in acting positions to fill the vacated positions

temporarily:

Hugh Lee, Acting Tribal Treasurer Wilkie Gregg, Acting FATCO General Manager Cheyanne Burnette, Acting Personnel Director; and Yvonne Redsteer, Acting Land Restoration Board

WHEREAS, the Tribal Council of the White Mountain Apache Tribe finds it in the best interest of

the Tribe to revisit this issue after commencement of the general election, pending the outcome of the investigation, and further finds that the position of Director of

Enterprise should be eliminated.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the following individuals shall temporarily be placed in the following acting positions:

Hugh Lee, Acting Tribal Treasurer
Wilkie Gregg, Acting FATCO General Manager
Cheyanne Burnette, Acting Personnel Director
Yvonne Redsteer, Acting Land Restoration Board

**BE IT FURTHER RESOLVED** by the Tribal Council that it hereby directs that the Director of Enterprises position should be eliminated.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>February 2, 2010</u> duly adopted by a vote of <u>NINE</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the
