



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Allowing TERO to Utilize \$2,500.00 for a Class)


- WHEREAS,** pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** the TERO office is charged with maintaining and enforcing the Tribal Labor Code; and
- WHEREAS,** Rovene Nosie proposed holding an apprenticeship program for sixty (60) people on February 9-10, 2011 because Tribal workers would benefit from training; and
- WHEREAS,** TERO does not have a separate budget to pay for such classes because all TERO fees collected go into the Central Tribe (01) account; and
- WHEREAS,** the training would cost \$2,500.00 and Mr. Nosie suggested that this amount be paid from the 5% TERO fee charged to all employers doing business on the Ft. Apache Indian Reservation; and
- WHEREAS,** the Tribal Council of the White Mountain Apache Tribe finds it in the best interest of the Tribe to allow TERO to hold the apprenticeship program on February 9-10, 2011 and that the \$2,500.00 fee be paid from the 5% TERO fees charged to all employers doing business on the Ft. Apache Indian Reservation.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves TERO to hold an apprenticeship program on February 9-10, 2011, and that the required \$2,500.00 be paid from the 5% TERO fees charged to all employers doing business on the Ft. Apache Indian Reservation.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **FEBRUARY 3, 2011** duly adopted by a vote of **NINE** for and **ZERO** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
