



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approval of Annual Leave Donations to Mr. Tony Lupe)**

**WHEREAS,** pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS,** Tribal Employees of the Cibecue Community Complex and other Departments have requested permission to donate annual leave hours to their co-worker, Mr. Tony Lupe; and

**WHEREAS,** Mr. Tony Lupe, an employee of the White Mountain Apache Tribe, as the Cibecue Complex Director, requires serious medical attention; and




