



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**( Appointing Fair and Rodeo Manager and Commissioners )**

- WHEREAS,** pursuant to Article IV, Section 1(a) and (s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and to appoint subordinate committees, commissions, boards, advisory or otherwise; and
- WHEREAS,** the Tribal Council of the White Mountain Apache Tribe acknowledges that a vacancy exists for a Fair and Rodeo Manager and Commissioners to help prepare for the 2011 White Mountain Apache Tribal Fair and Rodeo ("Fair and Rodeo") festivities; and
- WHEREAS,** Blaine Nosie has been nominated to serve as the Fair and Rodeo Manager through the conclusion of the 2011 Fair and Rodeo season; and
- WHEREAS,** Renell Williams, Nathaniel Joe Harvey, Bronwen Beatty, Bobby Billy Jr., Victor Walker, Ignatius Lupe Sr., Gary Hill and Ora Henry have been nominated to serve as Fair and Rodeo Commissioners through the conclusion of the 2011 Fair and Rodeo; and
- WHEREAS,** the Manager and Commissioners are responsible for setting up and managing the event as well as closing out the operation, maintaining the records for the event and should be granted exclusive authority to assume the responsibility for all expenditures; and
- WHEREAS,** the Tribal Council believes that the appointment of the above individuals, on a voluntary basis, is in the best interest of the White Mountain Apache Tribe and their participation will ensure that the 2011 Tribal Fair and Rodeo is a success.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby appoints Blaine Nosie as the Fair and Rodeo Manager for the 2011 Fair and Rodeo Season.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby appoints Renell Williams, Nathaniel Joe Harvey, Bronwen Beatty, Bobby Billy Jr., Victor Walker, Ignatius Lupe Sr., Gary Hill and Ora Henry to serve on a voluntary basis as Fair and Rodeo Commissioners through the conclusion of the 2011 Tribal Fair and Rodeo.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.
