



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**( Approving Reimbursement to Tribal Council Members for 2010 Fair and Rodeo Contributions )**

**WHEREAS,** pursuant to *Resolution No. 06-2010-160*, members of the Tribal Council were directed to donate \$500.00 ensure that the 2010 Fair and Rodeo festivities were a success; and

**WHEREAS,** several members of the Tribal Council contributed their own money towards the cause, including Kino Torino, Clinton Kessay, Jr., Troy Henry, and Reno Johnson, Sr.; and

**WHEREAS,** the Tribal Council now recommends that Resolution No. 06-2010-160 be rescinded due to only partial participation by the Tribal Council in this matter and that the contributing members be reimbursed for their contribution; and


**WHEREAS,** the Tribal Council finds that Councilmen Kino Torino, Clinton Kessay Jr., Gregg Henry, and Reno Johnson Sr. should be reimbursed the money they contributed to the 2010 Fair and Rodeo, due to lack of participation by the remaining members of the Tribal Council.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby rescinds *Resolution No. 06-2010-160* and directs the Tribal Council Secretary to reimburse those members of the Tribal Council that paid money towards the 2010 Fair and Rodeo.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **APRIL 7, 2011** duly adopted by a vote of **NINE** for and **ZERO** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (j), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
