



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approval to Grant Tribal Membership for Three Applicants)

WHEREAS, pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, pursuant to the Enrollment Code and the Tribal Constitution, the Tribal Enrollment Committee is designated to ensure that all requirements are met by each applicant that wishes to become an enrolled member of the White Mountain Apache Tribe; and

WHEREAS, on behalf of the Tribal Enrollment Committee, the Enrollment Officer presented a list of three applicants (per attached list) who have applied for membership with the White Mountain Apache Tribe; and

WHEREAS, the Tribal Enrollment Committee carefully reviewed each application and concluded that each applicant met the eligibility requirements; and


WHEREAS, the Tribal Council concurs with the recommendation of the Tribal Enrollment Committee and finds that the three applicants should be granted tribal membership.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the three applicants (per attached list), enrollment with the White Mountain Apache Tribe based on the recommendations of the Tribal Enrollment Committee, subject to rescission pursuant to the Tribal Enrollment Code Sections 1-202(a) and 1-704.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **APRIL 18, 2011** duly adopted by a vote of **SEVEN** for and **ZERO** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (g), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
