



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Adopting Tribal Member Hunting Regulations for 2011-2012)


- WHEREAS,** the Tribe's Wildlife and Outdoor Recreation Division, (WORD), did this day come before the Tribal Council to request that the Tribal Council adopt the Tribal Member Hunting Regulations for 2011-2012, as attached and incorporated by this reference; and
- WHEREAS,** WORD staff advised the Tribal Council that the hunting seasons, bag limits and regulations are based on sound biological principles, surveys and methods; and
- WHEREAS,** the Tribal Council has reviewed the recommended Regulations and concurs that the regulations will provide sustainable management of tribal wildlife resources; and
- WHEREAS,** the Tribal Council finds it in the best interest of the Tribe to adopt the Tribal Member Hunting Regulations for 2011-2012 as they protect the Tribe's natural resources located within the exterior boundaries of the Fort Apache Indian Reservation.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby adopts the Tribal Member Hunting Regulations for 2011-2012 as presented by WORD and referenced hereto.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **JUNE 1, 2011** duly adopted by a vote of **NINE** for and **ZERO** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (f), (h), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

- The Mule Deer waiting period for Zone 3A is now 1 year.
- The General Elk hunt tags are now available per Zone as opposed to reservation wide in order to redistribute hunters.
- Successful Special Bull tag applicants may now apply for other Zones, however the 5-year waiting period still applies for the Zone for which they were drawn.
- Zone 2 is excluded from the Junior Raghorn Bull hunt.
- Tribal members will now be able to turn in unused, antlered/horned big-game tags for an additional free entry into the draw of their choice.
- Elk urine is no longer allowed.
