



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Supporting Internet Crimes Against Children Taskforce Team)**

- WHEREAS,** the U.S. Department of Justice (DOJ) has announced the Internet Crimes against Children in Indian Country (ICAC) initiative to help law enforcement agencies develop an effective response to cyber enticement and child pornography cases; and
- WHEREAS,** the DOJ has selected the White Mountain Apache Tribe ("Tribe") to participate in a pilot program in furtherance of the goals stated herein; and
- WHEREAS,** an assessment needs to be completed to allow the Tribe access to funding; and
- WHEREAS,** there is a limited understanding and awareness of the Internet Crimes Against Children program as the partnerships needs to create an ICAC taskforce team plan for tribal communities; and
- WHEREAS,** there will be no Tribal contributions required to fund this project; and
- WHEREAS,** the ICAC Taskforce Team require critical partnerships between federal, state and local law enforcement, broadcast/media industry, department of transportation, schools, Tribal programs and other organizations to develop an effective response to cyber enticement and child pornography cases; and
- WHEREAS,** the White Mountain Apache Police Department, along with the collaboration of tribal departments, will design and develop a plan to initiate the ICAC program and Taskforce Team; and
- WHEREAS,** the plan will include the fulfilling the Tribe's needs in purchasing equipment, providing training and building interagency relationships; and
- WHEREAS,** the Tribal Council finds it in the best interest of the Tribe to authorize the Police Department to participate in the ICAC pilot program and further supports full implementation of the plans necessary to support the ICAC Taskforce Team.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby supports the Internet Crimes Against Children Program and that the governing body also recognizes that the White Mountain Apache Police Department is authorized to participate in this pilot project.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby supports fully the implementation of the plans for the Internet Crimes Against Children Taskforce Team and will continue such support until the program ceases or this resolution is rescinded.



**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **JUNE 1, 2011** duly adopted by a vote of **TEN** for and **ZERO** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
