



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approval to Grant Tribal Relinquishment Request of Teresa Mireau)

WHEREAS, Tribal Member, Teresa Mireau, has requested that her tribal membership with the White Mountain Apache Tribe be relinquished so that she may become eligible for enrollment with the Lummi Tribe; and

WHEREAS, the Relinquishment of Tribal Head Rights form has been completed and signed by Teresa Mireau in the presence of a Notary Public on March 23, 2011 (see attached); and

WHEREAS, the Tribal Enrollment Committee reviewed and approved this relinquishment request at a duly called meeting on April 19, 2011; and

WHEREAS, the Tribal Council concurs with the recommendation of the Tribal Enrollment Committee that the relinquishment from tribal membership be approved for Teresa Mireau.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Teresa Mireau, along with any and all privileges accorded to members of the White Mountain Apache Tribe such as, but not limited to, hunting, fishing, and recreational privileges upon the Fort Apache Indian Reservation.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Office of Vital Records to remove Teresa Mireau from the membership rolls of the White Mountain Apache Tribe.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on JUNE 9, 2011 duly adopted by a vote of SEVEN for and TWO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

I, Teresa Mureau, an enrolled member of the WHITE MOUNTAIN APACHE TRIBE, do hereby of my own free will, as an adult over the age of 18 years, voluntarily and with full knowledge of making this decision, request the TRIBAL COUNCIL of the WHITE MOUNTAIN APACHE TRIBE, FORT APACHE INDIAN RESERVATION, WHITERIVER, ARIZONA, to remove me from the Tribal Census Rolls of the White Mountain Apache Tribe to enable me to enroll with the Lummi Tribe.

Further, I understand that once my relinquishment is accepted by Tribal Council Resolution, it will be TOTAL AND IRREVOCABLE. I will no longer have fishing or hunting privileges on the Fort Apache Indian Reservation; no rights to homesite or farmland assignments, claim or title to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission Act. Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the resolution date accepting my relinquishment, all my livestock and personal property.
