



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approval to Grant Tribal Relinquishment Request of Dominique Diamond Russell)

WHEREAS, Tribal Member, Dominique Diamond Russell, has requested that her tribal membership with the White Mountain Apache Tribe be relinquished so that she may become eligible for enrollment with the San Carlos Apache Tribe; and

WHEREAS, the Relinquishment of Tribal Head Rights form has been completed and signed by Dominique Diamond Russell in the presence of a Notary Public on March 15, 2011 (see attached); and

WHEREAS, the Tribal Enrollment Committee reviewed and approved this relinquishment request at a duly called meeting on April 19, 2011; and

WHEREAS, the Tribal Council concurs with the recommendation of the Tribal Enrollment Committee that the relinquishment from tribal membership be approved for Dominique Diamond Russell.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Dominique Diamond Russell, along with any and all privileges accorded to members of the White Mountain Apache Tribe such as, but not limited to, hunting, fishing, and recreational privileges upon the Fort Apache Indian Reservation.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Office of Vital Records to remove Dominique Diamond Russell from the membership rolls of the White Mountain Apache Tribe.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **JUNE 9, 2011** duly adopted by a vote of **SEVEN** for and **THREE** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

FORM C RELINQUISHMENT OF TRIBAL HEAD RIGHTS
CHILDREN WHITE MOUNTAIN APACHE TRIBE
UNDER AGE 18 FORT APACHE INDIAN RESERVATION

I, Rosina Russell the parent of our child who is an enrolled member of the WHITE MOUNTAIN APACHE TRIBE, under the age of 15 years, do hereby, of my free will, as an adult over the age of eighteen years, voluntarily and with full knowledge of making this decision, request the TRIBAL COUNCIL of the WHITE MOUNTAIN APACHE TRIBE, WHITERIVER, ARIZONA, to release my/our child from the Tribal Census Rolls of the White Mountain Apache Tribe to enable my/our child to enroll with the San Carlos Apache Tribe.

Further, I understand that my child will no longer have fishing or hunting privileges on the FORT APACHE INDIAN RESERVATION; No home site or farmland assignments, or claim to have titles to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission Act.

Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the Resolution date accepting my child's relinquishment, any livestock in said child's name. I further understand, however, that my child may reapply for enrollment in the White Mountain Apache Tribe upon reaching the age of eighteen (18), but that the Tribal Council has total, nonreviewable discretion to deny or grant said reapplication.
