



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Authorizing Request for 45-day public comment period be initiated for the  
Water Quality Protection Ordinance, Chapter 3, Tribal Environmental Code)**

**WHEREAS,** the lakes of the White Mountain Apache Tribe are valuable natural resources that provide many benefits to the Tribe, including water quality, water storage-recreation, wildlife habitat, and scenic beauty; and

**WHEREAS,** on March 7, 2000, the Tribal Council adopted Water Quality Standards and enacted a Tribal Water Quality Protection Ordinance (Chapter 3, Tribal Environmental Code); and

**WHEREAS,** the Tribe's Water Quality Ordinance, Section 3.2 H, Public Hearings, mandates that the Tribe hold public hearings at least once each three year period for the purpose of reviewing, and as appropriate, modifying and adopting water quality standards; and

**WHEREAS,** the Tribal Council finds that the Water Resources Working Group undertake Public Hearings pursuant to Chapter 3 of the Tribal Environmental Code.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Hydrology and Water Resources and Environmental Protection Office is hereby directed to initiate a 45-day public comment period on the subject of the Tribe's Water Quality Standards, pursuant to Chapter 3 of the Tribal Environmental Code, and publish a notice of a hearing date at the District offices, the Legislative Council Office, the Apache Scout, and on KNNB broadcasts.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that notice of any and all public hearings be published at least 45 days prior to the scheduled hearing date.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that after public comments are addressed and the occurrence of the public hearing date(s) any and all proposed modifications to the Water Quality Standards to the Tribal Council for its review at the meeting of the Tribal Council that occurs after the public hearing date.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.


