



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**( Directing Hon-Dah Casino to Hire Roger Lupe, Jr., as Lead Painting Supervisor )**


- WHEREAS,** Mr. Roger Lupe, Jr., a Tribal Member, addressed the Tribal Council of the White Mountain Apache Tribe ("Tribe") concerning a missed employment opportunity with Hon-Dah Casino due to an error that was made on a job posting for the "Lead Painting Supervisor" position; and
- WHEREAS,** Hon-Dah management determined that it would be in the Tribe and Casino's best interest to remove the position and create a "General Maintenance" position instead, thereby depriving Mr. Lupe, Jr., of the opportunity to apply for the position as originally posted; and
- WHEREAS,** the Tribal Council discussed this issue at great length and determined that it would be in the best interest of the Tribe and Mr. Lupe, Jr., to direct Hon-Dah Casino management to hire Mr. Roger Lupe, Jr., as "Lead Painting Supervisor" at the rate associated with the job at the time it was originally advertised.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs Hon-Dah Casino management to hire Mr. Roger Lupe, Jr., for the position of Lead Painting Supervisor at a rate equivalent to that associated with the job at the time of the original posting.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **September 7, 2011** duly adopted by a vote of **FIVE** for, **ONE** against, with **THREE** abstaining by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (h), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
