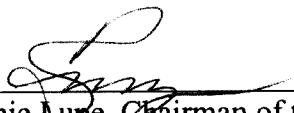

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Land Board meeting minutes for April 14, 2011.

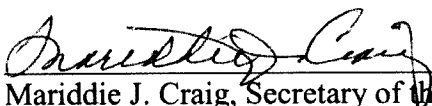

The foregoing resolution was on **SEPTEMBER 7, 2011** duly adopted by a vote of **NINE** for and **ZERO** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (h), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Meeting opened in Prayer by Nathaniel Narcisco, at 9:20 AM.

1. Lola Machuse – Requesting for land in Cibecue , near the junction coming into Cibecue. She stated that they use reside there years ago, and would like to get that land back. Stated that no one lives on that land at the moment. The board informed her that the is not suitable to build home on and should look for another site. Requested for another site near the tire shop, and this area is a small area but will look into it, was given an application and to return on April 28, for the meeting in Whiteriver.
2. John Lupe – Checking on his application and relinquishment for his children, Secretary informed him that the applications were finally approved and being signed, but will be mailed out as soon as we get it done.
3. Irene Murphy – Requesting for farmland that once belong to her mother, she stated she tried to let her brother and family know that they should use the field but no one is paying attention to it and would like to have it in her name. The field is near the river #26 and 1.99 acres, was in her late father's name, Alexander Nagle. Joe made motion to approve farmland for Ms. Murphy, Elvis, seconded and passed by a vote of 4 for and 0 against.

Chairman's family owns this land } Ms. Murphy requesting for another site in Cibecue, this is site is a public place where they have the sunrise dances, She stated that, she went to see the chairman and left with a heavy heart because the Chairman told her that the land belongs to him and his family. Raymus, and the board members told Ms. Murphy that this land was discussed at a prior meeting and also at the council meeting and was approved there that this area will be kept opened to the public and for the sunrise dances.

4. Elvis Cromwell – Requesting for a farmland in ^{Stockman} Canal that once belong to his mother. He wants this put in his brothers name, Baxter Cromwell. Joe made motion to put this farmland in Baxter's name and Paul second, passed with a vote of 4 for and 0 against, Another request on landsite in Whiteriver at the old fairgrounds. This landsite belong to James Palmer, who is now deceased . Elvis is requesting for his sister Larosa Palmer, she was married to James Palmer. Joe made motion to approve the request, Nathaniel 2nd it, passed with a vote of 4 for and 0 against.
5. Amos Tate – Applying for land that is being relinquished to him by his mother Lena Tate. Joe made motion to approve the relinquishment and Land Assignment, and Elvis 2nd , passed by a vote of 4 for and 0 against.
6. Anthony Bush – Renewing application for East Fork, Joe made motion to approve the application, Elvis 2nd it, pass by a vote of 5 for and 0 against.
7. Dennita Lupe/Danny Lewis – Mr. Lewis relinquishing farmland to his daughter Ms. Lupe, Joe made motion to approve the request, Elvis 2nd it, passed by a vote of 5 for and 0 against

8. Jacob Henry –Requesting for land at Mustang Ridge in Cibecue to put a soft ball field for the community. Raymus, informed him that it belong to Wilson Gregg Jr., so he would have to check with him on it.
9. Logan Lawson – Requesting for cornfield in near his house in Hollywood Hill at the rodeo grounds in Cibecue. Was given an application to fill out and return to Nathnaiel Narcisco for next land board meeting.
10. Chester Tessay – Requesting for farmland #5 in Salt Creek, This farmland belongs to M Henry, so he needs to apply for a farmland that don't belong to anyone.
