

## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

## (Authorizing Burial of Non-Tribal Member Eric Goode on the Fort Apache Indian Reservation)

WHEREAS, the Tribal Council of the White Mountain Apache Tribe was recently informed that Eric Goode, a non-tribal member and long time resident of Whiteriver and Cibecue, Arizona, recently passed away due to natural causes; and

WHEREAS, the Lewis family requests that the Tribal Council consider allowing Eric Goode to be buried on the Fort Apache Indian Reservation; and

WHEREAS, the Tribal Council finds that the Lewis family's request should be honored and finds it in the best interest of the Tribe to allow the burial of Eric Goode at the Open Range Cemetery in Cibecue, Arizona; and

WHEREAS, given the urgency of the need for proper authorization, the Tribal Council further finds that the burial request needs to be considered and made outside of its regularly scheduled meeting; and

WHEREAS, the Tribal Council further finds that: (1) this Resolution may be voted upon by signature of a member of the Tribal Council where a signature indicates a vote for this Resolution, (2) the Tribal Council Secretary should attempt to obtain signatures for members of the Tribal Council personally, (3) no signature would mean that the respective Tribal Council member is against this Resolution, (4) the Tribal Council Secretary should wait no longer than a reasonable period of time to obtain a vote by signature or by no signature and so indicate that this Resolution was presented to the respective member of the Tribal Council for a vote.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the burial of Eric Goode is hereby authorized to occur within the exterior boundaries of the Fort Apache Indian Reservation at the Open Range Cemetery in Cibecue, Arizona

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that given the urgency of the request described herein, this Resolution may be voted upon as follows: (a) by signature of a member of the Tribal Council, including the Chairman of the Tribal Council and the Vice-Chairman of the Tribal Council, where a signature indicates a vote for this Resolution, (b) the Tribal Council Secretary shall attempt to obtain signatures for members of the Tribal Council personally, (c) no signature shall mean that the respective Tribal Council member is against this Resolution, (d) the Tribal Council Secretary should wait no longer than a reasonable period of time to obtain a vote by signature or by no signature, and so indicate that this Resolution was presented to the respective member of the Tribal Council for a vote.

The foregoing resolution was on November 8, 2011 duly adopted by a vote of seven for zero and against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (h), (k), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
