



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving Third Continuance of Fiscal Year 2011-2012 Budget)**

**WHEREAS,** the Tribal Council previously approved a one-year tribal budget for the FY 2010-2011 budget year pursuant to Resolution No. 12-2010-328A; and

**WHEREAS,** as of this date, the Tribal Council is undertaking a review of program and enterprise budgets for fiscal year May 1, 2011 through April 30, 2012; and

**WHEREAS,** on July 6, 2011, the Tribal Council approved a sixty (60) day continuance of the FY 2011-2012 budget level and on August 3, 2011, the Tribal Council approved a second sixty (60) day continuance of the FY 2011-2012 budget level, both of which have expired; and

**WHEREAS,** the budget review for Fiscal Year 2011-2012 is not yet completed and for that reason the Tribal Council seeks a budget continuation to maintain program budgets at the Fiscal Year 2010-2011 level until such time as the review is completed; and

**WHEREAS,** the Tribal Council makes a strong recommendation that the Tribe should take measures to limit expenditures to essential costs (Salaries, Payroll Taxes, Utilities, and Fuel), which excludes any travel; and

**WHEREAS,** the Tribal Council finds that a continuance of the Fiscal Year 2011-2012 budget for a period of sixty (76) days, beginning October 31, 2011 through December 15, 2011, is in the best interest of the programs, enterprises and the Tribe and that said continuance shall continue in force and effect until such time as the Tribal Council may review and consider the Fiscal Year 2011-2012 budget; and

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that a continuance of the Fiscal Year 2011-2012 budget is hereby authorized for all Tribal Enterprises and Central Tribe departments for a period of sixty (76) days, beginning on October 31, 2011 through December 15, 2011, at a level not to exceed the Fiscal Year 2010-2011 budget level on a per month pro rata basis.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the continuance authorized herein shall continue until such time as the Tribal Council may review, consider and otherwise act on the Fiscal Year 2011-2012 budget.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

**Resolution No. 11-2011-228**

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **NOVEMBER 17, 2011** adopted by a vote of **NINE** for and **ONE** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (h), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
