



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approving Certification of the Primary Election Results)

WHEREAS, pursuant to Article IV, Section 8 of the Tribal Constitution of the White Mountain Apache Tribe, the Tribal Council adopted an Election ordinance which mandates that a Primary Election be held on the first Wednesday of February during an election year; and

WHEREAS, the Primary Election was held by the White Mountain Apache Tribe on Wednesday, February 1, 2012, wherein Tribal Council Candidates submitted their names to a vote of the people for Council Offices in Districts I, III, and IV; and

WHEREAS, the Tribal Election Commission has certified to the Tribal Council of the White Mountain Apache Tribe that the Primary Election is complete and has been carried out in accordance with provisions of the Tribal Constitution and the Election Code of the White Mountain Apache Tribe, and has certified that of the total of 2,569 ballots cast, the following number of votes were received by the individuals listed below whose names were on the ballot for the following offices:

WHEREAS, The Tribal Council concurs with the Certification of the Election Results presented by the Tribal Election Commission and concludes that the Commission's certification should be affirmed and accepted by the Tribal Council.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the certification of the primary election results submitted by the Tribal Election Commission for the Council Representatives for Districts I, III and IV are hereby accepted and the attached Certification of Election Results are hereby incorporated by reference herein.





The foregoing resolution was on **FEBRUARY 2, 2012** duly adopted by a vote of **SIX** for and **THREE** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (i), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
