

## WHITE MOUNTAIN APACHE TRIBE

A Sovereign Nation Exercising Self-Governance Over the Fort Apache Indian Reservation

## **Resolution No. <u>07-2012-109</u>**

(Assigning Land to Pedro and Lily Johnson)

WHEREAS, the Tribal Council of the White Mountain Apache Tribe ("Tribe") is entrusted by the

Tribe's Constitution to act in all matters that concern the welfare of the Tribe, to manage all economic affairs and enterprises of the Tribe, and to regulate subordinate

organizations for economic and other purposes; and

WHEREAS, the Land Board previously approved and recommended approximately 2.75 acres for

the benefit of Pedro and Lily Johnson, which consisted of a boundary that included

Farm No. 5 on Old Mission Ditch in Turkey Creek; and

WHEREAS, the Tribal Council finds it in the best interest of the Tribe to authorize the land

assignment as discussed and recommended by the land board.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes Pedro and Lily Johnson to make use of the land recommended by the land board which amounts to approximately 2.75 acres and includes Farm No. 5 on Old Mission Ditch located in the Turkey Creek area.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, this Resolution shall be declared null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution. In the event that the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign.

The foregoing resolution was on <u>JULY 11, 2012</u> duly adopted by a vote of <u>EIGHT</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (k), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribe September

30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
