



# WHITE MOUNTAIN APACHE TRIBE

*A Sovereign Nation Exercising Self-Governance  
Over the Fort Apache Indian Reservation*

## Resolution No. 08-2012-123

### ( Approval to Grant Tribal Membership for 51 Applicants )

**WHEREAS**, the Tribal Council of the White Mountain Apache Tribe ("Tribe") is entrusted by the Tribe's Constitution to act in all matters that concern the welfare of the Tribe and to regulate subordinate organizations for economic and other purposes; and

**WHEREAS**, pursuant to the Enrollment Code and the Tribal Constitution, the Tribal Enrollment Committee is designated to ensure that all requirements are met by each applicant who wishes to become an enrolled member of the White Mountain Apache Tribe; and

**WHEREAS**, on behalf of the Tribal Enrollment Committee, the Enrollment Officer presented a list of fifty-one (51) applicants (per attached list) who have applied for membership with the White Mountain Apache Tribe; and

**WHEREAS**, the Tribal Enrollment Committee carefully reviewed each application and concluded that each applicant should be granted tribal membership; and

**WHEREAS**, the Tribal Council concurs with the recommendation of the Tribal Enrollment Committee that the fifty-one (51) applicants be granted tribal membership.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the fifty-one (51) applicants (per attached list), enrollment with the White Mountain Apache Tribe based on the recommendations of the Tribal Enrollment Committee, subject to rescission pursuant to the Tribal Enrollment Code Sections 1-202(a) and 1-704.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, this Resolution shall be declared null and void and have no legal effect. This Resolution shall not be subject to Judicial Interpretation, only the Tribal Attorney, with the assistance of the Tribal Council Secretary, may opine on Tribal Council intent and the meaning of the language as used herein.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution. In the event that the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign provided that the Tribal Secretary and a Tribal Attorney attest to the veracity of the subject matter of this Resolution.


The foregoing resolution was on August 8, 2012 duly adopted by a vote of NINE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
