Resolution No. 06-2013-132

(Rescinding Resolution No. 04-1999-78 and Removing Judy Dehose from Haskell Board of Regents)

WHEREAS, pursuant to *Resolution No. 04-1999-78*, the White Mountain Apache Tribal Council appointed Judy DeHose to serve as a member of the National Haskell Board of Regents for the Haskell Indian Nations University; and

WHEREAS, at the time of her appointment as a Board member to the National Haskell Board of Regents, Judy Dehose was also a sitting member of the Tribal Council. As she no longer serves as a member of the Tribal Council, a question was posed to the Council as to whether it continues to be appropriate to have Ms. Dehose represent the Tribe on the Haskell Board of Regents; and

WHEREAS, based on the information discussed during today's meeting, the Tribal Council finds that it would be in the Tribe's best interest for them to rescind *Resolution No. 04-1999-78*, thereby absolving Ms. Judy Dehose of her responsibilities as a board member of the National Haskell Board of Regents; and

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby Rescinds Resolution No. 04-1999-78. Ms. Judy Dehose shall no longer be recognized as the Tribe's official representative on the National Haskell Board of Regents.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, this Resolution shall be declared null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution. In the event that the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign.


The foregoing resolution was on **JUNE 6, 2013** duly adopted by a vote of **FIVE** for and **ZERO** against and **TWO** abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
