## **Resolution No. 06-2013-139**

### **(Approving 2013-2014 Non-Member Hunting Regulations)**

**WHEREAS,** the Tribal Council of the White Mountain Apache Tribe ("Tribe") is entrusted by the Tribe's Constitution to act in all matters that concern the welfare of the Tribe, to manage all economic affairs and enterprises of the Tribe, and to regulate subordinate organizations for economic and other purposes; and

**WHEREAS,** the Tribe's Game & Fish Department did this day come before the Tribal Council to request approval of the Non-Member Hunting Regulations for 2013-2014, as attached and incorporated by this reference; and

**WHEREAS,** Game & Fish staff advised the Tribal Council that the hunting seasons, bag limits and regulations are based on sound biological principles, surveys and methods; and

**WHEREAS,** the Tribal Council has reviewed the recommended regulations and concurs that these will provide sustainable management of the Tribal Wildlife Resources; and

**WHEREAS,** the Tribal Council finds that the Non-Member Hunting Regulations for 2013-2014 are in the best interests of the natural resources within the Fort Apache Indian Reservation and the Tribe.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Non-member Hunting Regulations for 2013-2014, as attached and incorporated by this reference.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, this Resolution shall be declared null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution. In the event that the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign.

The foregoing resolution was on JUNE 20, 2013 duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (f), (h), (i), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
