Resolution No. 10-2013-197

(Accepting Michael Patterson’s Resignation as a Board Member for the Theodore Roosevelt School)

WHEREAS, the Tribal Council of the White Mountain Apache Tribe (“Tribe”) is entrusted by the Tribe’s Constitution to act in all matters that concern the welfare of the Tribe, to manage all economic affairs and enterprises of the Tribe, and to regulate subordinate organizations for economic and other purposes; and

WHEREAS, Resolution 07-2010-204 appointed Michael Patterson and several Parent Advisory Committee (“PAC”) members to serve as School Board members for the Theodore Roosevelt School (“TRS”); and

WHEREAS, School Principal, Michael Brock, informed the Tribal Council of Michael Patterson’s resignation as a member of the School Board; and

WHEREAS, the Tribal Council accepts Michael Patterson’s resignation and thanks Mr. Patterson for his service and contribution to the Theodore Roosevelt School Board.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby accepts the resignation of Michael Patterson as a School Board member for the Theodore Roosevelt School.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, this Resolution shall be declared null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution. In the event that the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign.


The foregoing resolution was on **October 2, 2013** duly adopted by a vote of **SEVEN** for and **ZERO** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
