Resolution No. 01-2014-15

(Approving Land Restoration Scholarship Award Recipients)

WHEREAS, the White Mountain Apache Tribe Permanent Land Restoration Code states that a portion of the

Permanent Land Restoration Fund is reserved for scholarships for Tribal members pursing

degrees in Natural Resources or related fields; and

WHEREAS, the scholarship recipients were selected in accordance with guidelines outlined in the Land

Restoration Code and the application process established by the Board; and

WHEREAS, the Land Restoration Board approves a scholarship award for each of the following recipients:

Charmayne Dayaye, Colleen George and Clayton R. Lupe.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby concurs with the Land Restoration Board and authorizes the Tribal Treasurer to issue scholarship awards to Charmayne Dayaye, Colleen George and Clayton R. Lupe with funds allocated through the Land Restoration's budget.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, or any material facts concerning the issues presented are later found to be false, this Resolution shall be declared null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution. In the event that the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign.

The foregoing resolution was on <u>JANUARY 21, 2014</u> duly adopted by a vote of <u>SIX</u> for, <u>ZERO</u> against, and <u>ZERO</u> abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (i), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
