Resolution No. 04-2014-49

(Authorizing Transfer of Ownership of Assigned Tribal Vehicles to Kino Torino, Cline Griggs, Gregg Henry, and Ronnie Lupe)

WHEREAS, the Tribal Council of the White Mountain Apache Tribe (“Tribe”) is entrusted by the Tribe’s Constitution to act in all matters that concern the welfare of the Tribe, to manage all economic affairs and enterprises of the Tribe, and to regulate subordinate organizations for economic and other purposes; and

WHEREAS, over the years, members of the governing body would receive their assigned Tribal Vehicles as a parting gift at the end of their respective terms; and

WHEREAS, in 2010, Resolution No. 05-2010-103 declared that all Tribal Vehicles were official property of the White Mountain Apache Tribe and no longer subject to gifting as was the practice of prior administrations; and

WHEREAS, the Tribal Council finds it appropriate to rescind Resolution No. 05-2010-103 and to transfer ownership of the Tribal Vehicles to the following members of the governing body: Kino Torino, Cline Griggs, Gregg Henry, and Ronnie Lupe.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby rescinds Resolution No. 05-2010-103, which prohibited the practice of gifting Tribal Vehicles to outgoing members of the governing body.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the request made to transfer ownership of Tribal Vehicles to the following members of the governing body, Kino Torino, Cline Griggs, Gregg Henry and Ronnie Lupe.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, or any material facts concerning the issues presented are later found to be false, this Resolution shall be declared null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution. In the event that the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign.


The foregoing resolution was on **April 24, 2014** duly adopted by a vote of **THREE** for and **TWO** against with **ONE** abstaining by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (i), (k), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
